ABSTRACT SUBMISSION GUIDELINES

The scientific committee of ISMPOCON 2022 invite the submission of abstracts for oral and e-poster presentations at the Annual Conference ISMPOCON 2022. The deadline for submission of abstracts is 10th January 2022.

Guidelines for submission:

- Prior registration for the conference is mandatory for the 1) paper to be accepted in the programme.
- 2) Selected abstracts will be published in the Indian Journal of Medical And Paediatric Oncology. The authors should ensure accuracy of scientific content, spelling and grammar, correct information of all the authors. No corrections will be permitted after submission and abstract will be published as submitted. It is presumed that the presenting author has the consent of all the co-authors.
- 3) Abstract should contain a maximum of 350 words. 1 figure and 1 table can be included. The abstract should be structured as follows:
 - Title
 - **Authors and affiliation**
 - Background information
 - Methods, results and conclusion
 - For case reports, please structure the abstracts as Introduction, Description and Conclusion
- The link for the abstract submission is "abstracts.ismpo.org" OR through the official website of the conference. Please register for the conference through the link provided at the bottom of the page before submission of the abstract.
- 5) The peer review and screening of the abstracts will be done by the conference committee and their decision will be final. Papers will be selected for oral or poster presentation based on merit and the authors will be notified by e-mail regarding the time of presentation.




